6.2 Adopt Capital Project Listing 2023/24 year

<u>Proulx:</u> Was wondering if veteran's banners could be paid for by TIFA funds? After discussion, it was decided to table this idea with banners all being private.

No builder wants to touch project without engineer specifications. Jon Sanford is guessing at least \$600,000 to rebuild that size of a structure. Nixon would like to see money added in TIF capital projects budget for the upcoming 2023/24 year for pavilion expenses. Maybe match ARPA money of \$80,000 out of General Fund.

<u>Sanford:</u> If ballfields do get moved, would like to see additional street lighting along Court Street and the sidewalks out to the soccer fields. Add on the capital project listing the same year as the ballfield relocation since it would be all done at same time or not done.

MOTION (Sanford) to adopt 5-year capital project listing for the TIFA fund adding in \$80,000 for pavilion renovations for the 2023/24 year; support (Popovich). Motion carried.

6.3 Adopt Budget Adjustments 2022/23 year
