ORDINANCE NO. 8

An ordinance to provide for a city Dog Warden for the City of AuGres and to prescribe the powers, duties and responsibilities of such officer; Also, to prescribe the responsibilities of dog owners or other parties keeping or harboring dogs within the corporate limits of the City of AuGres.

The City of AuGres ordains:

Section 1. It shall be unlawful for any person to own, possess or harbor a dog six months of age or over in the City of AuGres without first having obtained a license tag as provided for by the laws of the State of Michigan. Every person in possession of any dog, or who shall suffer such a dog to remain about his premises for the space of ten days shall for the purposes of this ordinance be deemed the owner thereof

Section 2. No dog shall be allowed to run at large in the City of AuGres unless said dog is under the reasonable control of the owner or a member of the owner's family. A female dog while in heat shall not leave the premises of the owner unless confined in the process of being transported to or from the premises of the owner.

Section 3. No person shall keep or harbor a dog which by loud or frequent or habitual barking, yelping or howling shall cause a serious annoyance or become a nuisance in the neighborhood or to people passing to and from upon the streets. No person shall be convicted under the provisions of this section (Section 3) of this ordinance except upon evidence of four (4) or more persons of different households.

Section 4. The City of AuGres shall employ a dog warden to enforce the provisions of Section 2 of this ordinance and to make complaints as required regarding the violation of any other section of this ordinance.

Section 5. All dogs placed under the custody of the dog warden, under this ordinance, shall be kept by said dog warden for at least ten (10) days, and if not claimed by the owner or owners before the expiration of this period, shall be disposed of by killing in a humane manner.

Section 6. No dogs shall be released by the dog warden until the owner of person entitled to demand the same shall pay to the dog warden an impounding fee of two (\$2.00) dollars and the further sum of one (\$1.00) dollar for the board and keep of said dog for each and every day or fractional part of a day, said dog has been impounded.

Section 7. The dog warden shall receive no salary from the City of AuGres but shall be paid seven (\$7.00) dollars for every dog disposed of according to the provisions of this ordinance. The City Council shall make provisions for the burying or other disposal of the bodies of all dogs that have been destroyed.

Section 8. No person, firm or corporation shall keep, operate or maintain a dog kennel within the limits of the City of AuGres without first having obtained a permit or a renewal of permit from the City Council, said permit or renewal to expire the 31st day of March following its issuance. A dog kennel as used in this ordinance means any establishment, wherein or whereon, more than three (3) dogs owned, kept or harbored for the purpose of breeding, sale or otherwise; said dogs being six months of age or older.

Section 9. If any of the sections of this ordinance shall be declared invalid by a court of competent jurisdiction, such invalidity shall not affect the remaining provisions hereof.

This Ordinance shall be published for two successive weeks in the Arenac County Independent after passage and prior to the effective date of March 15, 1957.

AMENDMENT TO ORDINANCE NO. 8

An Ordinance to provide for a City Dog Warden for the City of AuGres and to prescribe the powers, duties and responsibilities of such officer; Also, to prescribe the responsibility of Dog Owners or other parties keeping of harboring dogs within the corporate limits of the City of AuGres.

The City of AuGres ordains:

That Sections 5, 6 and 7 of Ordinance No. 8, passed on February 21, 1957, and amended on March 6, 1969, are further amended to read as follows:

SECTION 5. All dogs placed under the custody of the Dog Warden, under this Ordinance, shall be kept by said Dog Warden for at least five (5) days, or for such longer period as may be required by State Statutes, and if not claimed by the owner or owners before the expiration of this period, shall be disposed of by killing in a humane manner.

SECTION 6. No dogs shall be released by the Dog Warden until the owner or person entitled to demand the same shall pay to the Dog Warden an impounding fee of Five (\$5.00) Dollars, and the further sum of Two (\$2.00) Dollars per day for each day that such dog has been in the custody of the Dog Warden.

SECTION 7. The Dog Warden shall receive no salary from the City of AuGres but shall be paid the sum of Five (\$5.00) Dollars for every dog impounded under the provisions of this Ordinance, and the further sum of Two (\$2.00) Dollars per day for each day that such dog has been impounded by the Dog Warden. The City Council shall make provisions for burying or other disposal of the bodies of all dogs that have been destroyed under the provisions of this Ordinance.

This Ordinance was passed on September 6, 1973, at a Regular Meeting of the City Council of the City of AuGres. This Ordinance shall be published for two (2) weeks in the Arenac County Independent and shall become effective on October 1, 1973.
