# 1). CALL TO ORDER

# 7). AU GRES CITY POLICE CHIEF REPORT

# 8. OLD BUSINESS

# 8.1 Re-Zoning Request- Moore Builders

Nick Moore withdrew his re-zoning application to the City. With application withdrawn, no further discussion and just need a motion to close agenda item out.

# 9.1 Resolution: Riverfront Park Expansion Grant Match Agreement

Resolution needs to be passed and project agreement signed. This project consists of an additional two cabins, 28 concrete campsites, restroom building, landscaping and signage. DNRTF Grant is for \$400,000 with City commitment of \$200,000.

**MOTION** (Warr) to approve resolution for executing 2024 MNRTF Development Grant Project Agreement for the Au Gres Riverfront Campground with a commitment from the city of \$200,000; support (Barbour). Motion carried.

9.2 <u>Resolution Charitable Gaming License- Arenac County Celebration Fund</u> **MOTION** (Heinrich) to approve resolution for charitable gaming license to the Arenac County

Celebration Fund to hold a one-time Las Vegas night in the City; support (Warr). Motion carried.

# 9.3 TIFA Commercial Property Improvement Grant

TIFA Board has been working on a grant program for business owners to apply. This is set for a maximum grant of \$10,000 with a 1:1 match. Applications will be accepted now through March 31, 2026. A committee of City Manager, Mayor, 1 City Council member of John Popovich, 1 Planning Commission of Tom Nixon and 1 TIFA Board member of Dan Tolliver has been formed to process applications. TIFA Board will then approve applicants as suggested by committee at April meeting with deadline of city's fiscal year June 30 annually for project completion. Grant is only towards permanent

affixtures of building and/or grounds. If business owner is successful in obtaining grant, needs to wait three (3) years to re-apply.

**MOTION** (Warr) to approve TIFA Commercial Property Improvement Grant Program as submitted; support (Heinrich). Motion carried.

### 9.4 Kathleen McCartney Letter

Kathleen McCartney was present tonight to discuss letter she sent in to City in regards to a request to live stream City Council meetings on a social platform like facebook or youtube. She feels this is extremely important to increase awareness and transparency and allow for all those who are busy or out of town to participate. There is an isolation in the community and with the technology out there, why not? Jon Sanford explained the School Board looking into similar request and can piggy back off them what they come up with. City Manager will look into microphones and hoping to see something by first of year.

- Southcourt houses are scheduled for delivery end of November; foundation work should be starting shortly in preparation for arrival.
- Park Expansion project should be moving forward with materials coming in this month
- Post Office relocation in the former McDonald's building is still moving along and lease agreement has been made
- Halloween in the Park event- another great year!
- Ballfields- moved utility building and work being done by John McKenize and Dan Heinirch.
- Chamber nuts are in and available for \$25 per can.
