 access in the back connecting Bessinger Pickle to ATD building. They recently purchased
 Bessinger Pickle and part of the lot they are interested in has a section of the disc golf course
 located on it. City would be willing to work with them since it is great to see company
 expanding and options include them purchasing the lot and giving City easement for disc golf
 course section or get a survey done and split lot and have them pay the bill. City Manager will
 talk more with them on options and move forward since Council was in agreement to the
 property purchase.
