9). NEW BUSINESS

9.1 Yeo & Yeo Presentation Christina LaVielle

Christina LaVielle from Yeo & Yeo was present tonight to go over audit presentation for the 2024/25 fiscal year. City is in great financial shape and touched on highlights of General Fund, Sewer and Water Funds. General Fund revenue is comprised of 48% from taxes, 19% from State Revenue Sharing and the remainder with local contributions (9%), transfers (2%), charges for services (14%) and other revenue (8%). General Fund ended the fiscal year with a total fund balance of \$987,646.

Sewer fund had operating revenues of \$310,486 with operating expenses including depreciation of \$305,307 for a positive operating income of \$5179. Total fund balance for sewer fund is \$942,359. Water fund had operating revenues of \$392,499 with operating expenses including depreciation of \$301,620 for a positive operating income of \$90,879. Total fund balance for water fund is \$1,138,485. City's MERS Pension is at 89.79% funded and OPEB is 72.04% funded. City Council had no further questions. City staff & Council thanked Christina for coming up and doing the presentation.

9.2 <u>Rough Draft Civil Infraction Ordinance</u>

City Manager had rough draft of civil infraction ordinance that our new City Attorney Tim Freel provided for us to duplicate as we see fit. City Manager had a question on section 9. City Council members had no further comments just to check and see if fee structure could be established for each city ordinance-example; fee structure A is \$100 fine, etc. instead of first offense, second, etc. Dale will get with City Attorney. Once ordinance is approved it will need to be published in newspaper.

- Passed on his condolences to Joe Warr; nice send off for Sean Mattia with fire trucks, motorcycles, etc. in the procession.
- Building Department has not contacted Dale in regards to Ken Drive property. Dale did
 pull up EGLE permit and it showed approval to build a house on this property zoned
 wetlands. Dale feels City did their part by approving zoning; it is up to County Building
 Department now to enforce building codes. Building permit is coming up for renewal in
 September 2025.

- Southcourt lowest bidder was General Housing and meeting with them on Thursday September 4. City will be closing on the 4 properties September 8, 2025.
- Campground expansion- waiting to hear from Bilacic Trucking on start date.
- Dawn Senior Living- open house scheduled for September 6, 2025
- RiverMill Event Venue- ribbon cutting/open house scheduled for Sunday, September 7.
- Max Fox received his Eagle Scout. He put in and built the Gaga Ball Pit inside the City Campground; city will send an appreciation plaque to this ceremony. Eagle Scout Ceremony scheduled for Saturday, September 13, 2025.
- Rib Rally- went good this year and donated all money back to the ballfields, around \$6000 for dugouts. Dan Heinrich would like to send a thank you to this group for this donation.
